J Gitsham We should add the "Nature Conservation Society" to that list.

B Blaylock The "Field Naturalists" have a lot of properties around SA, but have a declining and aging membership. I believe that Birds SA should form a link with the "Field Naturalists".

S Brealey Benefits we seek are, getting access to expertise, such as, how to raise funds, strengthen

advocacy so that we have one strong message from the "conservation" movement and support with

"educational programmes". We need to avoid duplication of activities and progress to a

collaborative approach towards conservation issues.

J Gitsham One large voice is better than many smaller ones.

S Brealey I ask that the Committee Members read the material that was sent out, so that we can have further

discussion at the next Committee Meeting and identify individuals who can link with the various

conservation groups.

J Spiers I was the Birds SA Representative on the Conservation Council. After I resigned nobody else was

appointed. I believe that a Committee Member needs to represent Birds SA on the Conservation Council. This would require attending quarterly meetings and perhaps joining any relevant subcommittees. There is a "conservation sub-committee" that has access to the Minister for the

Environment on a regular basis.

J Gates I am prepared to attend the quarterly meetings of the Conservation Council as the Birds SA

Representative.
